**Approval of Previous Meeting Minutes**

The minutes of the October 23, 2008 STFNA Board meeting and the October 29, 2008 STFNA General meeting were approved unanimously.

### **Financial Report**

Rick Mandel presented the financial report for September 24-October 23, 2008 (Attachment 1). A summary of the financial status for the planned BEST scholarship program was also provided (Attachment 2). The BEST scholarship funds are in addition to the funds listed in the regular monthly budget report.

The reports were approved unanimously. Items not yet reflected in the status that will be added next time (Action Item 1) include:

- Monthly Budget reports will include a list of outstanding expenses such as receipts received but not yet paid and checks written but not yet included on the checking account bank statement. This will give us a better picture of funds that are already set aside for specific items. Monthly reports will also list income that is not yet deposited in the bank (such as dues received).
- Expenses for the printing of the newsletter are not yet reflected in the status. (~\$500).
- Expenses for the noise consultant for the Golf Course Event Tent project. This is a cost share with other neighborhood groups.

It is planned that the next STFNA Board meeting will include discussion of potential additional projects and estimated funding needs. (Action Item 2).

### **Feedback on October STFNA General Meeting**

There was a discussion of the October 29 STFNA General meeting. Some comments included:

- Attendance was very good (~74 people).
- The meeting was a little too long mainly because the agenda included so many items. Next time we plan to prepare the agenda to include time limits on each agenda item.
- Consider adding an agenda item for open comments from attendees. However, there will need to be a time limit of several minutes for each speaker.
- Question & answer sessions on an agenda item are useful though we will need to put a time limit on them so the meeting is not too lengthy.
- Attendees seem to be interested in communications with the police so this continues to be a popular agenda item.
- Allowing candidate statements during a meeting held near an election date is useful. However, based on an October candidate forum sponsored by STFNA and 2 other neighborhood groups, it may be difficult to get good attendance if this is the only topic for a meeting.

### **Welcome of New Board Members**

New STFNA Board Christine Kukielka was welcomed. She provided a summary with information on her experience and interests (Attachment 3). Matt Freeman summarized STFNA history and goals. Individual Board members in attendance introduced themselves.

The agenda of the next Board meeting will include Election of Officers (Action Item 3).

### **Website Changes**

The STFNA website is currently hosted on webmaster Danielle Spreier's server. This costs approximately \$100/monthly but the expenses were covered by Danielle's business. In the future, business changes will result in the need for STFNA to be on a different server, paid for by STFNA.

Danielle and Matt Freeman have investigated other options for the STFNA website. One option is to use a service provided by Wild Apricot. This is a server set up for clubs and groups and includes features such as:

- A blog where permissions can be set for who can update specific pages
- More automated tools for sending notices and managing the email list
- Discussion forum
- Ability for individuals to manage their own membership account including options to pay dues with a credit card.

The cost is estimated at about \$100/month but it varies by the number of members. It is possible that we could get local businesses to sponsor the website by purchasing ads.

Kathy Sutherland volunteered to contact the Neighborhood Development Center (NDC) to find out if they have plans for any community group websites with automated features. (Action Item 4).

Matt Freeman and Danielle Spreier will continue to investigate options including obtaining further information on features provided by Wild Apricot. This will include checking to see if the domain name stays the same and finding out more on the ability to limit permission for sending emails. (Action Item 5).

Since communication is very important for the success of our neighborhood association, we will need to review this topic at the next board meeting. (Action Item 6).

### **CAP Grant for Curie Drive Project**

Jacqueline Price has obtained an email with approval to redirect the grant funds to additional items related to the maintenance of the Curie Drive project. Matt Freeman will forward this email for the Treasurer's records and Recording Secretary's minutes (Action Item 7). Matt will also contact Jacqueline to confirm that we will continue the process that requires that any new grants will be reviewed with the STFNA Board prior to submittal of the grant application (Action Item 8).

### **Golf Course Event Tent Update**

John Hesler reported on the status of the proposed Boulder Ridge Golf Course request for an outdoor event tent. STFNA joined a number of other neighborhood associations to comment on this proposal. At the November 6 Planning Commission meeting, the status was provided and no action was taken. Also at the November 6 meeting, City Council member Nancy Pyle's letter was read and distributed. This letter expressed significant concerns with the proposal. The City Director of Planning expressed concerns during the meeting. The applicant and his attorney said they will modify the application to propose a permanent building rather than a tent.

It was significant that the Planning Commission directed the County staff to take the lead in setting up community meetings with the neighborhood associations and applicant to provide a forum for information and question and answer sessions.

John will continue to monitor this issue and keep us informed.

### **BEST Scholarship Update**

Dave Smith provided an update on the plans for a proposed scholarship program funded by Beautify Everything Santa Teresa (BEST) events. A committee meeting was held in November to discuss the proposed program and criteria. The meeting was attended by Dave Smith and 3 other volunteers. The committee proposed the following:

- Criteria for scholarship includes:
  - Student must live within the geographic boundaries of STFNA
  - Student must attend Santa Teresa High School and be a Junior or Senior
  - Student must have GPA of 3.5 or higher
- Decision on selecting the winner for the scholarship was recommended to be made at an STFNA General meeting. The students applying for the scholarship would present their essay at the meeting. A vote would be taken by a random selection of approximately 20 meeting attendees.

The committee did not make any recommendation on whether the scholarship fund was to be viewed as a gift or as a loan to the student. The amount of the scholarship was not decided.

The Board thanked Dave for his successful fund raising including donations from the BEST event this summer and auctioning of several donated items at the General meeting.

There was some discussion of items including whether students from other high schools could be included, whether a committee should select the scholarship winner rather than random STFNA General meeting attendees and what types of future fundraising activities could be held (raffles, e-waste collection events, BEST event with high school musicians providing entertainment in backyards of our neighborhood).

Santa Teresa High School involvement is important and Dave has been in contact with the head counselor. Christine Kukielka volunteered to contact an English teacher to obtain her input. (Action Item 9)

The topic of the scholarship program will be added to the December STFNA Board meeting agenda for further discussion (Action Item 10).

Devony – Hi – boy, the wheels of bureaucracy move very slowly sometimes. Since you last sent me this email – I have had to deal with new people at the city level, our city forest and San Jose Conservation Corps. It has been very time consuming.

Each and every one have come back with new information and quotes so unfortunately I need to ask the steering committee to consider and hopefully approved the re-distribution of the remaining \$1295.00 as follows:

Decomposed Granite – replacement and stamping and Sandstone replacement on 5 park strips

Conducted by members of San Jose Conservation Corp: \$868.00

Good Morning Jacqueline,

Project 1: One 2-person crew will have to use a jack hammer and shovel to breakup the hardened DG (\$672.00 labor for two days). The DG cost from Payless Nursery is \$91.00 a yard and the Flagstone cost is \$0.21 per pound. I believe it will take 1-yard of DG and about 10 pieces of Flagstone (each weighing 50 pounds); material cost will be \$196.00 (\$91.00 + 105.00 + tax). Total Cost for Project 1 is approximately \$868.00 (\$672.00 + \$196.00).
